3. During either the August or September Business meeting, each individuals/couples running for Baron and Baroness will be given 5 minutes to discuss their goals/vision for the Barony. 4. On or about 1 October, mail the pollings to the paid SCA members of the Populace and the membership roster to TRM.

5. On or about 1 November, last day for pollings to be received by TRM. Remember that in accordance with Kingdom Law, your polling must be signed with you legal modern name and your SCA and modern name printed legibly.

6. No later than 1 December, have a new Baron and Baroness announced to the Populace. This is my goal and will depend on the will of TRM. This will give us 2 1/2 months to incorporated the new Baron/Baroness's wished into their investiture which is currently planned for the end of February.

Second, I will be attending the Northern Atlantia Calendar Meeting on the 26 July 2003. At this meeting, we will be setting up the event calendar for Northern Atlantia for the next year. Unto the Barony of Ponte Alto, greetings and wishes for every good fortune from Master Kevin of Thornbury, Knight Marshall!

At Curia, Their Royal Majesties have amended the previous ruling regarding modern attire on the field of combat. Specifically, no article of equipment may be blatantly modern. All attempts must be made to cover modern equipment.

II Tempo This is basically a five-foot rule. We're used to hearing this regarding garb, but what it means is that anything spotted to be modern at five feet away will not be allowed.

This new law will be enforced by the inspecting marshal on the day of the event. PLEASE NOTE: This applies to everyone on the field of combat except for the water bearers. This includes armored combatants, rapier combatants, archers, marshalls, etc. The effective date for the law with this new amendment is now December 1st.

I anticipate some growing pains as we all work towards making out best effort at period recreation of combat and the tournament. Check your Acorn in the coming months for University classes relating to the interpretation of this new law.

Lastly, I wish to thank the barony for their support as I come out of my long struggle with unemployment. I look forward to seeing you all with renewed vigor.

Minutes of Baronial Business Meeting held June 29th, 2003:

Meeting was called to order at 6:06pm, 29 in attendance.

The Seneschal deferred to His Excellency. His Excellency announced that he and Baroness Denise will be unable to serve as Baron and Baroness beyond their current term, due to mundane considerations. They will serve out their current term as fully as possible.

Seneschal: Results of Curia: 1. In order to get a hard copy, request one from the Kingdom Clerk of Law. 2. A new award, the Golden Gazelle, was established for members age 17 and under for courtesy. 3. Event announcements in the Acorn should be limited to 1 page if possible. 4. Publication of The Oak will move from the Chronicler to KMoAS.

Regarding polling for a new Baron and/or Baroness, we will take nominations at the July business meeting. At August and September meetings, nominees may make short statements concerning their goals and ideas for the Barony. They may also submit brief statements to be published in II Tempo. Polling will be sent to the residents of the Barony in September. The results will be sent to Their Royal Majesties no later than the end of October. We hope for a decision from Their Majesties by December. Investiture will take place in February. Also, we need an autocrat for this event!

Exchequer: Balance is \$4,707.83. Our financial policy passed Kingdom requirements. Now we must vote to reconcile the Baronial Charter with these changes, which mirror the Kingdom's financial policy. Voted to allocate up to \$150 for expenses for the polling for our next Baron and Baroness. Voted to allocate \$283 for our storage room for the next 6 months.

Chronicler: II Tempo happens. Q2 report has been sent to Kingdom Chronicler.

MoAS: 1. Thanks to Peronelle for hosting sewing night. 2. Ponte Alto had 13 members teaching 17 classes at university. Good work! 3. Scriptorium is on hold. Harp and Drum is on hold until after Pennsic. Alle Psalite will continue through July. 4. Competitions at Coronation will focus on the 1492-1600 time frame. 5. The A&S competition theme at Chalice of the Sun God will be "A Gift for a Lady". Also, competitions for Baronial brewer, bard, and artisan will be held. 6. The November German themed event will definitely have a musical competition. 7. Scriptorium may be changed to a general A&S night once a month. Will decide after Pennsic. 8. There will be another baronial picnic on Sunday, July 27th, at fighter practice location.

MoL: No events, therefore nothing to report, but Agnes has helped out as MoL at other fighting events in the area.

Marshall: 1. Curia decided to require that all blatantly non-period armor (plastic, etc) must be covered with cloth or leather, with the exception of safety gear. This rule is for everyone on the field (marshalls, fighters, etc) except waterbearers. This rule will take effect December 1st. 2. There were 48 heavy fighters and over 25 rapier fighters at Windmasters Hill event. 3. You can still authorize for Pennsic at either Assessment, Storvik Novice Day, or Last Chance.

Rapier: Lots of fighters at university. 3 people are training as rapier marshalls. Week night practices will take place on Thursdays at Tysons-Pimmit park until September. Then we will return to Shrevewood Elementary School for week-night practices, also on Thursdays.

Archery: Held our first archery practice at our new location last Wednesday night. There will be no practice on July 18th, or during Pennsic. Thanks to Rene for hosting the practices. Please contact Feline for directions, other information.

Herald: No news, but heraldry happens.

Baron: He has ordered 10 helmets. 7 are ready. See him to borrow or purchase. The Baron wants lots of participation from Ponte Alto fighters on the battlefields at Pennsic. Tabards will be available. There is unlimited attendance and tent camping, but the dining hall will only hold 90.
